### Hilda Gage Judicial Excellence Award Nomination – Instructions

The Michigan Judges Association (MJA) is accepting nominations for the Hilda Gage Judicial Excellence Award. The award is named in honor of the late Judge Hilda Gage. Judge Gage served on the Oakland Circuit Bench and the Court of Appeals before passing away in 2010. Renowned for her courage, scholarship, and public service, Judge Gage was the first female President of MJA and the first female chairperson of both the Judicial Tenure Commission and the National Conference of State Trial Judges of the American Bar Association.

The Hilda Gage Judicial Excellence Award recognizes a sitting or retired circuit or court of appeals judge that has demonstrated:

- Competence in docket and trial management;
- Contributions to the legal profession;
- Contributions through legal scholarship;
- Dedication to community service.

Nominees must have been a member in good standing with MJA at the time of their service on the bench.
